Clerk Blot read a letter aloud from Helene O'Clair, thanking the Village for establishing the Life Reach Program. She also submitted a donation to the Colonie Fire Department.

New hire Mitchell Relyea was present and introduced by Superintendent Decker. Mr. Relyea is our newest laborer working for the Department of Public Works.

Mayor Sim mentioned that we have been meeting daily to discuss the numerous COVID-19 issues. This pandemic is changing constantly, and we are gathering as much information so that

we can properly prepare how to handle this going forward. We are looking into reducing staff by 50%.

Mr. Casey announced that the news just stated that the March 18, 2020 Village election has been postponed until April 28, 2020, to which the board and Clerk will look into for more information.

Trustee Tobin mentioned that the sponsor letters have gone out for the 2020 Concert Series. He also noted that all bands are in place but two.

Chief Kayser stated that there will be a county wide conference call at 7 p.m. tomorrow night with all the fire chiefs to discuss COVID-19 measures.
