Fire Department Report – January 2021

Clerk Blot noted that due to the Presidents Day holiday, the next regularly scheduled board meeting will be held on Tuesday, February 16, 2021 at 10:00 a.m.

Trustee Lockart mentioned that the Senior Center will be having a drive-by Valentines Day luncheon. Children form Forest Park school are making Valentines for the seniors that will be included with their lunch.

Trustee Sim mentioned we have a snow emergency in effect which started at noon today and will be in effect until 7:00 a.m. Wednesday. There should be no parking on any Village streets during the emergency.

Mayor Tobin mentioned that seniors did a "double" lunch today in anticipation of the snowstorm. Anyone who ordered lunch for Tuesday, received it today, to ensure the seniors have plenty of food and to keep them off the roads in messy conditions. Mayor Tobin also gave a brief COVID update in relation to our daily operations. He stated that the Village hall staff is at 50% capacity and teleworking for the other 50% of staff, the DPW is split into 2 shifts, one from 7:00 a.m. – 3:00 p.m. and the other from 6:00 a.m. – 2:00 p.m. with a staggered lunchbreak. All other departments can resume normal schedules, but are asked to continue distancing and wearing their masks.
