Mayor Tobin thanked the committee adding it was a lot of hard work. Deputy Mayor Sim added that it was a lot to do in half the time it usually takes to plan such a purchase and there were a lot of difficult decisions to be made.

Superintendent Decker mentioned that the DPW crews will be going out and trying to cut the snow curbs tighter and knock back some of the snowbanks. He said the ice made it tricky.
