Mayor Tobin requested Attorney Caponera give a brief overview of the Hoffman request for re-zone which started with a public hearing that was held by the Mayor and Board of Trustees on May 16, 2021. Attorney Caponera stated that he has gone through all the minutes, documents and correspondence regarding this proposal. Attorney Caponera stated that the back portion of land known as 1755 Central Avenue, owned by HDC2 Realty 1755 Realty, LLC or more commonly known as Hoffman's Car Wash, is land locked. Originally he said the owners were asking the board for approximately 15,000 sq. ft. of property to be re-zoned into commercial usage from residential. After recognizing the property is landlocked, the planning commission recommended to the Mayor and Board that to rectify the current commercial use of the pavement existing in that area, a smaller portion could be considered for re-zone. It was recommended by the planning commission that 10,500 sq. ft. of land be re-zoned Commercial A, from Single Family Residential. This is a 60' x 175' area in the back of the property. Attorney Caponera stated that if this resolution is approved, the owner will need to return to the planning commission, at which time further stipulations may be imposed. Several residents requested a better map depicting the area to be re-zoned, to which Attorney Caponera stated it is something that will be addressed on the planning level. Resident Mark Stevens requested the planning minutes and agendas be updated more regularly on the website, to which the Mayor and Board said they would address this concern. Clerk Blot stated she will speak with the coordinator and that she will pass on the names of the residents she has been in contact over the years regarding this matter. She asked if everyone got the letter regarding this meeting, to which everyone did. She added that the same mailing list will be used with any future meeting held by the planning commission. She said they meet the 1st and 3rd Tuesday of each month, and anyone is always welcome to call Village Hall to see what is intended for the agenda.
