All present congratulated Mr. Normandin on his appointment and welcomed him. Trustee Lockart thanked the fire Chief for the use of the fire house for the “gun-back” program. She said about 20 guns were regained, and that the program in Watervliet did really well.

Mayor Tobin said the summer villager will be our shortly, and noted the carnival will be here starting May 18th.

Chief Kayser said that the fire department participated in the recruit NY program at the highschool with 4 out of the 6 local departments. He added they plan to do a meet and greet in the future. He said as an outcome of the recruit NY event, they had about 8-10 teens interested in becoming volunteers, and hopes they continue on with the program. He said the open house this year is planned for June 3rd, and instead of focusing on mainly kids, they plan to also focus on teens, since we can recruit starting at 16. He added we need to capture more youth, earlier. Chief read the April 2023 fire report. Deputy Mayor Sim asked the Chief is the striping is done on 406, to which the Chief said that all repairs and finish work is complete on 406. Clerk Blot reminded the Chief that the 2022 point earning checks for the annual service award will go out this week.
