Clerk Blot mentioned we received a letter from Chief VAVS Erwin Dominquez thanking the Village of Colonie and all those who donated during the months of November and December 2024 during our "Giving Tree" that was held at our senior center.

Mayor Rubino added that he was really pleased with the outcome of all our Veterans outreach events that we've held so far. The response for the vets has been great. He thanked all who have been involved.

Chief Kayser read aloud the December 2024 fire report and gave his end of the year figures for the department. He said the department had 505 calls for the year. He added that Wendy's located at 1770 Central Avenue has a faulty detector and he has been there several times, and they won't address the issue. Mayor Rubino said that he will meet with Chief Kayser and Building Chief Meservey to discuss. Chief Kayser also said that they fire department had to shut down Dairy Queen, located on Central Avenue due to a faulty gas leak.

Chief Kayser requested that the Board consider increasing the nuisance fees. He said that the fire department has been dispatched to Wendy's for this faulty alarm 4 times in the past 17 days. He stated fire alarms, especially faulty ones are a large draw on manpower. He added that prior to the meeting, he was called to Maharaja, for an alarm.

Deputy Mayor Lockart asked that when we notify about these faulty alarms is it corporate or the local business being notified?

Chief Kayser said the board would have to verify with Chief Code Officer Meservey, but he believes it's sent to the local business and then corporate if necessary.

Chief Kayser mentioned that the department did a Toys for Tots donation for the holiday season, and they also helped some of the families in the two Village schools, and was surprised to learn there are a lot of needy families in our schools, who didn't want toys, but just clothes and shoes. He said the department wants to do more to help Village families, so this upcoming year they are going to focus their attention on helping needy families in the two village schools.

Mayor Rubino wished everyone a Happy New Year. He added that we had a great year last year and thanked everyone for their cooperation. He also noted that the ice-skating rink is coming along and has been being enjoyed the past few weekends.
