Regarding Resolution 2025-38: Mayor Rubino said that the pump station changes have been turned over to the engineer's insurance company for review and approval. This resolution is to cover the expenses of the change orders to tie up any loose ends and should be reimbursed with the settlement of the insurance claim.

Regarding Local Law #4 of 2025: Chief Code Enforcement Officer Meservery said that the proposed code is regarding the hoarding concern within the Village. Clerk Blot added that park of the Local Law is to change the speed limit on Sand Creek Road to 25 mph.

Trustee Lockart said she received a comment from a neighbor on Sunset Boulevard about the change of speed on Sand Creek Road and saw a thread on social media regarding the change. She informed the person on Sunset Boulevard about the meeting, and it was relayed in the social media post, and there was no one in attendance at the meeting.

Deputy Mayor Prevratil spoke about lowering the speed limit on Sand Creek Road saying it could possibly save lives.

Trustee DePaulo and Trustee Stevens both said they are in favor of the decrease in speed on Sand Creek Road.

There were no further questions or comments from the board or public.

Trustee Stevens made a motion to close the public hearing.
