MINUTES MINUTES OF THE MAYOR AND BOARD OF TRUSTEES MONDAY, AUGUST 18, 2025 6:30 P.M.

The meeting of the Mayor and Board of Trustees was held on Monday, August 18, 2025, at 2 Thunder Road, Albany, NY 12205. Deputy Mayor Prevratil opened the meeting at 7:01 p.m. with the Pledge of Allegiance.

Minutes of the public hearing held on August 4, 2025, regarding Resolution 2025-52, were reviewed by the present members of the board.

A motion was made by Trustee Lockart to approve the minutes, as presented. The motion was seconded by Trustee Stevens.

NYS taxation and finance, and did not include the late fee of \$7.50, and was requested authorization to waive the late fee.

Clerk Blot requested a vote on Resolution 2025-58 "Recommendation to deny peddlers permit request."

Clerk Blot explained that she received a request for two peddlers permit from the same company, who wishes to go door-to-door in the Village of Colonie for roofing services. Her recommendation to deny is based on our past practice of not issuing permits for this type of solicitation. With a vulnerable population of seniors, she feels that if people want that type of service, they can find it on their own accord.

To that matter, Mayor Rubino said that if any residents don't feel comfortable answering the door, he advised them not to. He said that our residents have got in the habit of knowing we don't issue these types of permits. He also stated that if a Village employee should come to their house, they should have identification on them, and to ask for said identification. He also encouraged residents to call the police of any suspicious persons.

She did add that if approved, they would be required to also inform the Colonie police of the event.

Mayor Rubino thanked everyone for attending the public hearing. He stated that tomorrow there is a concert at Cook Park, at 6:30 p.m.

Trustee Lockart said that last week was the end of the summer program, they had a great season. The summer ended by painting ceramics. She added that the staff had a lot of dedication and was a great program this year.

Trustee Stevens said that the fire department is up stuffing envelopes at the moment preparing for this year's turkey raffle, adding that the fire department does a great job, and asked all to please consider donating if they get the raffle tickets in the mail.

Mayor Rubino added that supporting the fire department is important, stating that they are volunteers who do a tremendous amount of work and are always there when we need them. He said that he hopes everyone will consider making a donation.

Chief Kayser thanked the Board for their support. He added that the department responded to a cardiac arrest last Tuesday, and was able to perform a reversal, 52-year-old male. He also stated that the fund raising that the department does, goes back to the community. He said that the fire department gets solicitated to donate to various organizations throughout the year, which they participate. They also support the two local Village elementary schools, Saddlewood and Forest Park with various initiatives throughout the year, and the donations that they receive help to make these initiatives possible.
